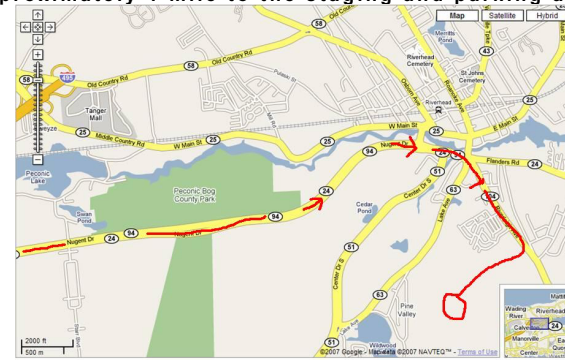
Bitches in season are not eligible for entry in any Hunt Test and are not allowed on the grounds.

From the Long Island Expressway eastbound, take Exit 71. Turn right at stop sign onto Nugent Drive Rt23. Travel approximately 4 miles to the Peconic Avenue Traffic Circle (immediately adjacent to the Riverhead business district), then south on County Rt 104 the 2nd right in the circle (Small Sign). Approximately 1/10 mile, south on CR 104, is the Sarnoff Preserve sign and entrance on the west (right) side. Proceed through the gate to the parking lot approximately 1 mile to the staging and parking area.
